WHEREAS: Whereas,
The mission of the Vision of the Free Methodist Church is "To bring wholeness to world through healthy biblical communities of holy people multiplying disciples, leaders, groups and churches."
This Vision and Mission rests on the faith, actions, and commitment of the local church.
The bishops of the Free Methodist Church serve in spiritual leadership of these efforts and administrative services of the FMCUSA support and coordinate the efforts of the local church.
Realizing the Free Methodist vision and mission will result in growth at the local church level, through discipleship and numerical growth.
Local churches will experience financial growth associated with their discipleship and numerical growth.
The Equal Participation Payment (EPP) paid by local churches is a long-established means of covering denominational overhead.
Historically the EPP assessment has been 3.2%.
Any increase in the EPP will reduce resources at the local level available to execute the mission and vision of the Free Methodist Church.
The Equal Participation Plan (EPP) within the FMCUSA is a plan that should have the entire organization's input since all societies are required to fulfill the requirement.
The members of the FMCUSA expect the leadership to give a full accounting and detailed presentation in regard to a request to raise the EPP assessments placed on upon FMCUSA churches.
The best and most sustainable means to support expanding administrative overhead is through the addition of new societies and members.

Therefore, BE IT RESOLVED:				
That stated in Paragraph 4360 under General Church Funding the following shall be added:				
"Any change in the EPP shall require discussion on the General Conference floor, and approval of the Conference Delegate by an affirming vote of 2/3s."
