| The retired Elder has a wealth of ministry experience and gifting available to the local church. |
| At present there is no direction for the stewardship of retired Elders in the Book of Discipline. |
| Therefore, BE IT RESOLVED: |
| "Whenever a Ministerial Education and Guidance Board, in its annual review of pastors, determines that a retired Elder has no involvement in the Free Methodist Church for two consecutive years, the retired elder forfeits the right to vote at the annual conference. This shall not pertain to the enactment of P. 5220.M by the Ministerial Education and Guidance Board. |
| This shall not pertain to retired Elders who have notified the Ministerial Education and Guidance Board that they are serving a church outside the Denomination and the Ministerial Education and Guidance Board has approved of such service. This shall not pertain to elders in extenuating circumstances (i.e. health of the elder, or lack of a FM church nearby.) The Ministerial Education and Guidance Board shall have the sole prerogative on such matters and the restoration of voting privileges." |
