Whereas: ¶7120 states, "If an accusation is shown to be true, all action by the church is designed to lead to repentance, forgiveness and return to fellowship with God and the church and,

Whereas: ¶7130.B states, "When there is a breach of order, the response, of the church shall be directed toward both the offender and those harmed" and,

Whereas: The process of restoration in too many Annual Conferences has in the past lead to a "one and done" mentality that saw the minster/Elder removed but not restored and,

Whereas: The process of restoration, in practice, varies from Conference to Conference

## Therefore, BE IT RESOLVED:

That each Annual Conference MEG Board and Denominational Regional Review Board shall use a restorative practice model of

restoration(<u>https://en.wikipedia.org/wiki/Restorative\_practices#Restorative\_conferences</u>), which works to build healthy communities, repair harm and restore relationships.

And be it further resolved that all members of the Annual Conference MEG Boards and Regional Review Boards shall be required to receive training in conducting restorative practice within the Conference year that coincides with the close of the 2023 General Conference.
