WHEREAS:

- Whereas the normal pathway for representation in the General Conference is contingent up membership in an Annual or Provisional Annual conference;
- And whereas there are existing churches in the world where it is politically not possible to form Annual Conferences;
- And whereas in these existing churches the disciples are following the Articles of Religion of the Free Methodist Church and are being actively discipled;
- And whereas the leaders of these churches are ordained members of the Free Methodist Church USA in a particular world area, but not of a formed Annual Conference or Provisional Annual Conference;
- And whereas these are some of the most fruitful works under the jurisdiction of the Free Methodist Church USA;
- And whereas it seems to wise to have the presence, vote and voice of this portion of the church at our General Conference gatherings;

Therefore, BE IT RESOLVED:

- The general formula used for representation for annual and provisional annual conference be used to determine the number of delegates from these mission areas;
- Be it further resolved that the number of lay representatives cannot exceed the number of elders from the mission area as is consistent with paragraph 4040.A.;
- Be it further resolved that Board of Bishops will receive the recommendation from the Area Director to make a determination of the number of delegates to be included in the General Conference delegation from mission areas based on the number of ordained elders and disciples being formed the from the mission area.
- Be it further resolved that the following paragraphs be inserted into the Book of Discipline as paragraph 4030.A.1 and 4030.A.2.

4030.A.1 Mission areas not under an Annual Conference or a Provisional Annual Conference but meeting the markers for an Annual Conference or a Provisional Annual Conference as described in paragraphs 4560 and 4570 may be entitled to representation at the General Conference as delimited in paragraphs 4030 and 4040.

4030.A.2. The Board of Bishops shall receive the recommendation from the Area Director to make a determination of the number of delegates to be included in the General Conference delegation from mission areas described in Paragraph 4030.A.1 based on the number of ordained elders and disciples being formed the from the mission area.
